1 INTRODUCTION AND SUMMARY

This is a Final Rate Order of the Ontario Energy Board (OEB) on an application filed by Lakefront Utilities Inc. (Lakefront Utilities) to change its electricity distribution rates in 2017.

On December 8, 2016, the OEB issued a Decision and Order (Decision) outlining the final parameters that Lakefront Utilities' should use to calculate its rates to be effective January 1, 2017. Lakefront Utilities filed a draft rate order implementing the OEB's Decision. The draft rate order included detailed supporting information showing the calculation of final rates. OEB staff and intervenors were given an opportunity to make comments on the draft rate order.

OEB staff commented that there were two minor inconsistencies between the Chapter 2 Appendices and the figures for capital expenditures and OM&A in the draft rate order. OEB staff also noted Lakefront Utilities' should update the proposed Tariff of Rates and Charges for 2017 regulatory charges and wording enhancements. In its reply comments, Lakefront Utilities agreed with OEB staff and provided an updated draft rate order addressing OEB staff's comments.

The OEB has reviewed Lakefront Utilities' revised draft rate order and proposed Tariff of Rates and Charges, and is satisfied that they accurately reflect the Decision.

As a result of this Rate Order, it is estimated that the total monthly bill for a typical residential customer with an average monthly consumption of 750 kWh will increase by 0.61% or \$0.88.

2 THE PROCESS

Lakefront Utilities filed a draft rate order on December 15, 2016. Parties were given the opportunity to provide comments on the draft rate order. OEB staff filed comments. Lakefront Utilities responded to comments and filed a revised draft rate order on December 28, 2016.

3 RATE ORDER

The OEB has reviewed the information provided in support of Lakefront Utilities' revised draft rate order and proposed Tariff of Rates and Charges. The OEB finds that the Tariff of Rates and Charges in Schedule A accurately reflects the Decision and is consistent with the OEB's format.

This Rate Order establishes Lakefront Utilities' distribution rates effective January 1, 2017.

4 IMPLEMENTATION

Pursuant to the approval by the OEB of the terms and cost consequences of the OEB Decision, the new rates are effective January 1, 2017.

5 ORDER

THE ONTARIO ENERGY BOARD ORDERS THAT:

1. The Tariff of Rates and Charges set out in Schedule A of this Rate Order is final effective January 1, 2017. The Tariff of Rates and Charges will apply to electricity consumed or estimated to have been consumed on and after January 1, 2017. Lakefront Utilities shall notify its customers of the rate changes no later than the delivery of the first bill reflecting the new rates.

RESIDENTIAL SERVICE CLASSIFICATION

This classification refers to an account taking electricity at 750 volts or less where the electricity is used exclusively in a separately metered living accommodation. Customers shall be residing in single-dwelling units that consist of a detached house or one unit of a semi-detached, duplex, triplex or quadruplex house, with a residential zoning. Separately metered dwellings within a town house complex or apartment building also qualify as residential customers. Class B consumers are defined in accordance with O. Reg. 429/04. Further servicing details are available in the distributor's Conditions of Service.

APPLICATION

The application of these rates and charges shall be in accordance with the Licence of the Distributor and any Code or Order of the Ontario Energy Board, and amendments thereto as approved by the Ontario Energy Board, which may be applicable to the administration of this schedule.

No rates and charges for the distribution of electricity and charges to meet the costs of any work or service done or furnished for the purpose of the distribution of electricity shall be made except as permitted by this schedule, unless required by the Distributor's Licence or a Code or Order of the Ontario Energy Board, and amendments thereto as approved by the Ontario Energy Board, or as specified herein.

Unless specifically noted, this schedule does not contain any charges for the electricity commodity, be it under the Regulated Price Plan, a contract with a retailer or the wholesale market price, as applicable. In addition, the charges in the MONTHLY RATES AND CHARGES - Regulatory Component of this schedule do not apply to a customer that is an embedded wholesale market participant.

It should be noted that this schedule does not list any charges, assessments, or credits that are required by law to be invoiced by a distributor and that are not subject to the Ontario Energy Board approval, such as the Debt Retirement Charge, the Global Adjustment and the HST.

ONTARIO ELECTRICITY SUPPORT PROGRAM RECIPIENTS

In addition to the charges specified on page 1 of this tariff of rates and charges, the following credits are to be applied to eligible residential customers.

APPLICATION

The application of the charges are in accordance with the Distribution System Code (Section 9) and subsection 79.2(4) of the Ontario Energy Board Act, 1998.

The application of these charges shall be in accordance with the Licence of the Distributor and any Code or Order of the Ontario Energy Board, and amendments thereto as approved by the Ontario Energy Board, which may be applicable to the administration of this schedule.

In this class:

"Aboriginal person" includes a person who is a First Nations person, a Métis person or an Inuit person;
"account-holder" means a consumer who has an account with a distributor that falls within a residential-rate classification as specified in a rate order made by the Ontario Energy Board under section 78 of the Act, and who lives at the service address to which the account relates for at least six months in a year;
"electricity-intensive medical device" means an oxygen concentrator, a mechanical ventilator, or such other device as may be specified by the Ontario Energy Board;
"household" means the account-holder and any other people living at the accountholder's service address for at least six months in a year, including people other than the account-holder's spouse, children or other relatives;
"household income" means the combined annual after-tax income of all members of a household aged 16 or over;

Class E

Class E comprises account-holders with a household income and household size described under Class A who also meet any of the following conditions:

- (a) the dwelling to which the account relates is heated primarily by electricity;
- (b) the account-holder or any member of the account-holder's household is an Aboriginal person; or
- (c) the account-holder or any member of the account-holder's household regularly uses, for medical purposes, an electricity-intensive medical device at the dwelling to which the account relates.

GENERAL SERVICE 50 TO 2,999 KW SERVICE CLASSIFICATION

This classification refers to a non residential account whose monthly average peak demand is equal to or greater than, or is forecast to be equal to or greater than, 50 kW but less than 3,000 kW. Class A and Class B consumers are defined in accordance with O. Reg. 429/04. Further servicing details are available in the distributor's Conditions of Service.

APPLICATION

The application of these rates and charges shall be in accordance with the Licence of the Distributor and any Code or Order of the Ontario Energy Board, and amendments thereto as approved by the Ontario Energy Board, which may be applicable to the administration of this schedule.

No rates and charges for the distribution of electricity and charges to meet the costs of any work or service done or furnished for the purpose of the distribution of electricity shall be made except as permitted by this schedule, unless required by the Distributor's Licence or a Code or Order of the Ontario Energy Board, and amendments thereto as approved by the Ontario Energy Board, or as specified herein.

Unless specifically noted, this schedule does not contain any charges for the electricity commodity, be it under the Regulated Price Plan, a contract with a retailer or the wholesale market price, as applicable. In addition, the charges in the MONTHLY RATES AND CHARGES - Regulatory Component of this schedule do not apply to a customer that is an embedded wholesale market participant.
